EDFW 2022 Proposed Operating Budget Narrative

The Operating Budget for the Diocese is used for the daily operations of the Diocesan Center, provides for the ministry of the Bishop and allows the Diocesan staff to support and serve the congregations and ministries of the Diocese.

Income

Parishes and Missions: The 2022 budget was based upon an assessment formula of 12.75%. The same formula that was used for the 2021 operating year. The full assessment formula is explained on the attachment. The difference between 2020 and 2021 assessment is -\$63,000. We continue to seek to move the Diocese towards a flat 10% assessment in the years ahead.

Mission Apportionments: This is income paid by a mission to assist with the clergy stipend paid by the Diocese.

Endowment for Episcopate: This is annual investment income from the Endowment set aside for the ministry of the Episcopate.

Special Gifts: The increase in special gifts is reflective of projected income from the proposed missionary district.

Strategic Plan Fund: This is income from the Strategic Plan budget that will be transferred to the Operating budget to fund Strategic Plan "Pillar" activities that are part of the Operating Budget.

Expenses

General Church: We have committed to a 10% tithe to the Province. (ACNA)

Episcopate: These are expenses related to Bishop Reed's ministry as well as assisting Bishops.

Building Operation: Expenses related to the maintenance and operation of the Diocesan Center Building and Grounds.

Office Operation: Expenses related to the internal administrative and operational needs of the Diocesan Center.

Personnel: Diocesan Staff that oversee the day-to-day support of the Bishop and the Diocese. Including financial, communication, youth and administrative staff.

Diocesan Support: Expenses related to Diocesan Curacies (4 in 2022) and those seeking ordination. In addition, support for meetings such as Convention and ACNA assembly.

Missions: Grants to mission churches to assist with clergy stipend.

Diocesan and Community Ministries: Support given to Diocesan and Community Ministries for activities related to outreach and ministry. (Some of these are related to Strategic Plan Pillars)

PROPOSED ASSESSMENT FORMULA 2022

Canon 16 of the Diocesan Canons gives the Executive Council authority to assess parishes and missions to meet the Diocesan budget as adopted by the Diocesan Convention.

The formula used by the Executive Council to determine the assessment of each parish and mission of the Diocese is proposed as follows:

BASE: Operating Income as reported on the Annual Parochial Report Form for the Year **2020**. (item #46)

10% for all churches on the first \$50,000.00 of income.

12.75% on that portion of income that exceeds \$50,000.00.

NOTE: Operating Income includes::

- 1. Plate Offerings
- 2. Pledge Payments from membership
- 3. Contributions from Congregation's Organizations
- 4. Net Operating Investment Income
- 5. Other <u>Operating</u> Income, including unrestricted gifts and restricted gifts <u>used for operations</u>
